

Election results will be declared at the Club's AGM held on Thursday 23rd April 2015.

FIRST ORDINARY RESOLUTION

- "(a) That pursuant to the Registered Clubs Act the members hereby approve and agree to expenditure by the Club in a sum not exceeding (\$80,000) over the following 12 months until the next Annual General Meeting of the Club for the following expenses subject to approval by the Board of Directors:
 - (i) The reasonable costs of Directors attending seminars, lectures and other educational activities as determined by the Board from time to time
 - (ii) The reasonable costs (including travel and accommodation expenses and other reasonable out of pocket expenses) of Directors attending meetings, conferences and trade shows conducted by ClubsNSW, the Clubs Directors Institute, the Club Managers Association and the RSL Clubs Association and such other conferences and trade shows as determined by the Board from time to time.
 - (iii) The reasonable cost of Directors attending any other registered club for the purpose of viewing and assessing its facilities as determined by the Board as being necessary for the benefit of the Club.
 - (iv) The reasonable cost of Directors and partners of Directors attending any club, club industry, community or charity functions as representatives of the Club and authorised by the Board to do so and the reimbursement to Directors of reasonable out of pocket expenses when representing the club at these functions.
 - (v) The reimbursement of reasonable out of pocket expenses incurred by Directors travelling to and from any additional or special Board meetings or other duly constituted meetings of any committee of the Board.
 - (vi) The reasonable cost of a meal and beverages for each director before and after a Board or committee meeting on the day of that meeting when such meeting coincides with a normal meal time.
 - (vii) The reasonable expenses incurred by Directors either within the Club or elsewhere in relation to such other duties including entertainment of special guests of the Club and other promotional activities approved by the Board on production of documentary evidence of such expenditure.
 - (viii) The reasonable cost of Directors entertaining guests whilst they are on duty at the Club provided such entertaining is limited to meals, beverages and internal shows.
 - (ix) The reasonable cost of supplying Directors with a Club blazer, a Club tie, trousers and a Club shirt.
 - (x) The provision of designated car parking spaces for Directors in the Club's car park.

(b) The members acknowledge that the benefits in paragraph (a) are not available for members generally but are only for those who are Directors of the Club."

NOTES TO MEMBERS ON THE FIRST ORDINARY RESOLUTION

1. The first Ordinary Resolution is to have the members in general meeting approve various expenditure by the Club for Directors including to attend seminars, lectures, trade displays and other similar events to be kept abreast of current trends and developments which may have a significant bearing on the Club and for other out of pocket expenses. Included in the First Ordinary Resolution is the cost of Directors attending functions as representatives of the Club and the costs of their spouses/partners also attending those functions.

SECOND ORDINARY RESOLUTION

"(a) That the members hereby approve the payment of the following honorariums to the Directors of the club for services as Directors of the Club until the Annual General

Meeting in 2016:

- (i) President \$10,000.00; and
- (ii) Directors \$4,000.00 each.
- (b) Such honorariums to be paid by monthly or other instalments as the Club and President and director may agree from time to time.
- (c) If the President or a director only holds office for part of the term, the honorarium shall be paid on a pro-rata basis."

NOTES TO MEMBERS ON THE SECOND ORDINARY RESOLUTION

1. The Second Ordinary Resolution is to have the members at the General Meeting approve honorariums for the Directors of the Club for duties to be performed by them until the next Annual General Meeting. However, the honorariums will be paid on a pro-rata basis which means that a director who only holds office for part of the year will only receive part of the honorarium. The honorarium proposed this year for the President is \$10,000 and for Directors is \$4,000 which is in recognition of the many hours of voluntary service provided by the President and the other Directors in attending to the Club's business.

THIRD ORDINARY RESOLUTION

That the members approve Ingleburn RSL Club adsorbing, to a maximum of \$500, the catering cost of the wake of any Life Member of the Club held at the premises of the Club.

PROCEDURAL MATTERS IN RELATION TO ALL THE ORDINARY RESOLUTIONS

- To be passed each ordinary resolution must receive votes in its favour from not less than a simple majority of those members, who being entitled to do so, vote in person at the meeting.
- Under the Registered Clubs Act, members who are employees of the Club are not entitled to vote.
- 3. Proxy voting is prohibited by the Registered Clubs Act.

NOTE TO MEMBERS REGARDING FINANCIAL QUERIES

Members who wish to raise any queries or seek information at the Annual General Meeting about the Financial Report or other matters pertaining to the affairs of the Club, are asked to give the Chief Executive Officer notice in writing of their queries or requests by Friday 17th April 2015. This will enable properly researched replies to be prepared for the benefit of Members.

PRESIDENT'S REPORT

Dear Members.

Here we are again at the end of another year and what an exciting year it has been. It is again my pleasure to present to you, my report for the year 2014. Firstly, may I state that your Club ended the year in a financially sound and healthy state an outstanding result, with a profit of \$1,629,675. This is of course due to your wonderful continued patronage of your Club and the ongoing initiatives and management skills of your Chief Executive Officer, Mr. Glenn Cushion, his outstanding management team and our hard working and dedicated staff. Whilst this is certainly an excellent result, it must be remembered that such profits will be spent in the continued refurbishment of the Club house and its external areas. In recent times the lending authorities have become reluctant to advance loans to Licensed Clubs. It is now essential that Clubs generate enough funds to satisfy their own needs with finance, where expenditure is required to maintain what our members expect of their Club's amenities.

During the year a number of small alterations were made in the layout of different areas of the Club's interior and further such renovations will continue during 2015. Although no major projects are intended in the coming months, however some major works are in the pipe line that will further enhance the amenities being provided to the members in the future. Due to the age of the Club, there is ongoing maintenance requiring extensive expenditure to keep the Club in a satisfactory state and in a condition that meets the members' expectations and requirements.

On 7th June 1975 you Club was officially opened by the then Governor of NSW, the late Sir Roden Cutler VC. The plaque commemorating this event can be found on the first pillar at the Club's main entrance. Within our memorial cabinets is a small framed article which contains a one dollar note, this is our very first dollar that was passed over the bar on opening day all those years ago (the cost of a schooner was \$1.10). On the note are the signatures of a number of members that were there at the time, many are still with us now. The Club site and building will be 40 this year and is still going strong. Hopefully with many more years to come, to continue to provide the entertainment and services the members now enjoy.

The Club's units at Forster are still being enjoyed by a large number of the members. Many of the units have been refurbished with new furnishings and internal painting in many has brightened them up.

I must again reiterate to all members, your Club's stern attitude to its responsibilities as to the RSA and RCG laws. The Club's Management and staff at all levels will strictly enforce these laws surrounding the NSW Legislation at all times. Whilst it is your Clubs most earnest wish for all its members to enjoy the benefits of being a member, there is a small minority of members that appear to have little regard for their fellow members and do not adhere to these regulations. May I reassert that any violence, anti-social or intoxicated behaviour will not be tolerated at any time and any such behaviour may well result in the cancellation of any offending members' Club membership. It is pleasing to note that the greater majority of our members do comply with the regulations and are enjoying the benefits of being a member.

Your Club has again during 2014 assisted numerous organisations with monitory grants and in kind. This has been and will always be a part of your Clubs continuing community support program and will remain for the future.

We have had a number of staff leave our employ over the past twelve months. To those former employees may we wish them every success in their new roles. To all new employees, we say welcome to the team. We hope the association is a long and happy relationship.

The kitchen has been very busy in 2014 and looks to be even more so in 2015 with a new menu arriving in early March. Thank you to Rob and Lisa, our expert caterers and their dedicated staff in continuing to provide such fine food in the Clubs restaurant.

On 25th April 2015 will this year, be the most important date in this decade, being a hundred years that our troops first stormed ashore in the predawn darkness on the little beach at ANZAC Cove on the Gallipoli Peninsular, during the early years of world war one. It is anticipated that this Dawn Service will, no doubt be the biggest ever held here at Ingleburn and no doubt, across Australia to commemorate this event. Our Sub Branch members will be busy ensuring the service is as always conducted in the most solemn and dedicated manner and with great respect to our fallen diggers and in memory of all our fallen in all theatres of conflict the country has been in over the decades and on this morning, in particular the heroic numbers that landed on that little strip of sand in that far off country on this morning in 1915.

Congratulations to our Sub Branch President, Mr. Ray James on his election to the NSW RSL State Council as a State Councillor for the Sydney Metropolitan area. May we extend our best wishes to all our Sub Branch members for a healthy and prosperous 2015.

In closing, I would like to express on behalf of your Board, our sincere congratulations to our Chief Executive Officer, Mr. Glenn Cushion for the great work and results he has achieved for your Club over the past twelve months. It is a result of his initiatives, inspiration and hard work that has given your Club such a satisfactory result for the end of the year of 2014. To you Glenn, we say thank you. This also extends to your management staff and indeed all our staff for their great effort in their individual dedication to their duties, which has contributed to this result. To you we also say thank you.

To my fellow Directors, thank you for your continued support during the year and for your dedication to your assigned duties.

In conclusion may we express our gratitude to you, our Club members for your continuing patronage and support for without this your Club would be unable to maintain the current facilities and entertainment being provided.

TREASURER'S REPORT

I take this opportunity to present as Treasurer of Ingleburn RSL Sub-Branch Club Limited, the results for the period ending 31st December 2014. The Club made a profit of \$1,629,675 (2013: Profit \$1,222,692) a result that we can all be proud of.

I would like to thank the Chief Executive Officer, Mr. Glenn Cushion his PA, Mrs. Tanita Coulter and his team for their continuing support through the year 2014 as it has been a very rewarding year in hard times as we see other Clubs going under. I would like also to thank Mrs. Jenifer Collins for her support as she is a professional asset to myself and the Club. Well done all. I would also like to acknowledge the support of the Board Members — thank you.

STATEMENT OF COMPREHENSIVE INCOME

The entity's total revenue has increased by \$1,103,807 (8.23%) since the prior year.

Whilst total expenses have increased by \$408,023 (3.75%) resulting in a net profit after tax of \$1,629,675 (income tax: NIL) compared to \$1,222,692 (income tax: NIL) for the previous year.

Individual items that have impacted the 2014 result include:

Net clearances from poker machines increased by \$1,089,980.

Gaming duty increased by \$291.928.

Interest received increased to \$42,657.

Bar sales have decreased by \$55,902.

Cost of sales has decreased by \$9,214 as a result of decrease in sales.

Entertainment, marketing and promotional costs decreased by \$22,978.

Employee benefit expenses increased by \$275,041.

Depreciation and amortisation expenses increased by \$310.857.

Donation expenses increased by \$73,109.

STATEMENT OF FINANCIAL POSITION

The entity's net asset have increased by \$1,629,675 or 18.07% since the previous year consisting of an increase in total assets of \$1,740,798 and a \$111,123 increase in total liabilities.

This increase/decrease in net assets for the year is mainly attributed to:

Increase in property, plant and equipment including leasehold improvements was \$1,444,890, less the difference between depreciation and amortisation of (\$1,482,531) resulting in the net additions of \$37,641.

Increase in receivables of \$70,481.

Increase in cash and cash equivalents by \$1,711,324.

Decrease in inventories by \$3,366.

Increase in employee benefits provision of \$275,041.

CASH FLOW STATEMENT

Operating activities provided net cash flow of \$3,219,599 an increase of \$1,711,324 or 87.78% when compared to the previous year.

Net cash used in investing activities of \$1,444,890 related to payments for property, plant and equipment including capital works, renovations and leasehold improvements also Bank Loan mortgage repayments were \$63,385.

As a result of these cash flows, the net cash held during the year increased by \$1,711,324 compared to the previous year's increase of \$346,153.

Cash at year end was \$3,661,035 compared to \$1,949,711 in the prior year.

The Club is moving in the right directions in difficult and hard times and it is pleasing the Board, Management and staff work as hard as they do to achieve the results we have this year.

The ongoing challenge for 2015 is to continue to consolidate our financial position, continue to work to achieve the goals in our Strategic Plan to maintain our Club. We look to our future to have a better and more profitable Club so that you, our members may enjoy and be proud of Ingleburn RSL Club. Again, I would like to thank my fellow board members and the Chief Executive Officer and his team, our staff for their efforts and support in 2014. I would also thank all of our loyal members, you make the Club. Let's all have good 2015.

CHIEF EXECUTIVE OFFICER'S REPORT

It is a privilege to serve with a dedicated Board of Directors, loyal members and to lead a Management team, and the staff that we have at Ingleburn RSL Club. Combined, we have achieved another successful year on the back of hard work and dedication. Our club for the second year running has achieved a profit that has increased again this year. The profit in 2014 for your club was \$1.63 million. Whilst this result is pleasing, we will continue to work hard to grow our business striving to improve to become as efficient as we possibly can.

This result is one that has been delivered after careful consideration by the Board in the strategy and direction the club would take. Late in 2013 the Board and Management developed and implemented a Strategic Plan setting many goals and targets specifically designed to make our business more robust and to achieve growth. We operate in a very competitive and mature environment further challenged in some areas of our business by a declining market. This means every opportunity that is there or becomes available must be taken to reach our goals, objectives and potential.

Over the past two and half years many decisions have been made to direct our club on a course to achieve the results we strive to achieve. This could not have occurred without the cooperation and support of all stakeholders and our gratitude extends to each and every one of them.

Resting on our laurels is not on the agenda and in January 2015 a Development Application was lodged with Campbelltown City Council. The planned works when undertaken will renovate and extend the Crystal Lounge Outdoor Gaming area, a new bar, carpet, back of house, administration and new male and female amenities in the lower level of the same lounge. The work is scheduled to commence in May after Anzac Day and be completed in September of this year. I would like to take this opportunity to thank the Sub Branch and in particular their Executive and Trustees who worked with us in the pre development application part of this project.

Many members may not be aware that our club land and building is owned by the RSL Sub-Branch and the lease is overseen by the Trustees. This presents club Management and the Board of Directors with an ongoing challenge to build our business to one day be in a position to offer to purchase from the Sub Branch. This is, a major goal of the club's strategic plan and the reason we must continue to make our business efficient and profitable so that we can be in a position to move forward with an offer. With an ageing building, limited areas for development in the current building, little option to diversify, purchasing the land and building from the Sub Branch will set a course to master our club, the members and the communities destiny with this asset. It is very important to state at this time any offer from the Club to the Sub-Branch would be just that, an offer for consideration. Any sale to the club would see ongoing Sub Branch accommodation and operation subject to a deed, in other words, certainty for the Sub Branch and their members. We are after all an RSL club that works closely with a well run and vibrant Sub Branch.

Anzac Day this year marks the 100 year anniversary of the landing at Gallipoli. This once in a lifetime event presents the entire community the chance to commemorate, celebrate and communicate with each other about how special this day is on our national calendar. On behalf of everyone at Ingleburn RSL Club we encourage you to join us for our Dawn Service followed by a day of tradition at the club. Please remember, if you plan to have a drink with us on Anzac Day, we ask that you enjoy responsibly and always consider others.

In what is another milestone this year we celebrate 40 years since the then Governor General Sir Roden Cutler opened a brand new club building here at Chester Road on the 7th June 1975. He was joined by the Prime Minister on the day and Local Member Gough Whitlam, President Doug Purser and Secretary Manager Len Toms, along with hundreds of members, local families and children in what was a watershed event for the Ingleburn Community. In June of this year we will celebrate our 40th anniversary with member specials, giveaways, entertainment and a major promotion. Please keep an eye on our website and advertising for details closer to June.

We are very proud and conscious of our ongoing commitment and contribution to Community support in our local area. Once again we have supported through cash and in-kind donations a large number of applicants. Last year we achieved support in the amount of \$400,000.00 up once again on the year prior. The Boards desire to support our community remains a priority and already this year our commitment and action for community support is robust. A full list of community support recipients are contained in this report and are also available on our club website.

There are always so many people to thank for helping to make Ingleburn RSL the club that it has become as we work to build an even more successful community asset. I take this opportunity to thank all of our contractors, your contribution, dedication and support is invaluable. Our staff team is without doubt friendly, dedicated and loyal, striving to deliver a great experience for our members and guests. A special thank you to the Management team for your hard work and loyalty and to my PA Tanita Coulter, thank you for your total support and the wonderful job you do.

Our President Ray Williams leads a Board of six other Directors who have the best interest of the club underpinning their dedication for Ingleburn RSL. The success achieved in the 2014 financial year and the strategic vision the Board has, starts with each of directors and as I mentioned at the beginning of this report it is indeed a privilege to be guided and directed by them. I would also like to mention and acknowledge the support I have received from the Board in what has been a challenging period personally and for my family. I sincerely thank and acknowledge this support from them, our staff, trade and members, and I trust I can repay this in the period ahead.

SUB-BRANCH REPORT

2014 has been a very busy year for Ingleburn RSL Sub Branch. The membership of our Sub Branch increased as well with both former and serving members joining us. Throughout 2014 we held numerous commemorative events that started with the 99th Anniversary of the landing at Gallipoli. Once again we saw record numbers of over 4,000 people attending the ANZAC Day Dawn Service. The Denham Court Church Service on ANZAC Day also had a larger than expected crowd in attendance.

In May we commemorated the Battle of Coral / Balmoral (Vietnam May/June 1968). This service was well attended by people from all over Australia and New Zealand.

On the 8th of November we held the Military Gala Day. This event commemorated the 100 years since the 1st AIF disembarked for Egypt, Gallipoli and the Western Front. The day included various marching bands, military working dog display, military equipment/vehicles and cadets. The highlight of course was the RAAF Roulettes who soared above Wood Park and the Club. Later in the day we were joined by His Excellency General the Honourable David John Hurley AC DSC, Governor of NSW, his wife Linda Hurley, Mr Keith Payne VC OAM and his wife, Florence Payne OAM. They were joined by our Sub Branch members, other dignitaries and members of the community at a plaque unveiling service. This was held in the Memorial Garden and newly named Sister Haultain Memorial Park. Following this service Wood Park again took centre stage as Soldiers and Airmen from the School of Military Engineering, with support from the Australian Army Band (Sydney), conducted a traditional 'Beat The Retreat' ceremony in front of a mock Castle. This ceremony ended with a massive fireworks display.

On the 11 November we held the Remembrance Day Service that again was well attended. Once again we saw a large crowd gather to commemorate this solemn ceremony.

As President of Ingleburn RSL Sub Branch I am amazed and pleased at the growing numbers of those who in the community who come along to commemorate the services we hold throughout the year. All those who attend, both young and old, show dignity and reverence at these services. It is also great seeing our local schools sending students in uniform to attend and pay their respects.

We lost eleven of our Sub Branch members in 2014. They will be sadly missed and our prayers are with their families. Our welfare and pensions officers continued to work hard throughout the year as their services were called upon more frequently.

Our Executive and Management Committee worked hard throughout the year. They were assisted by numerous members of our Sub Branch in ensuring our events were successful. I cannot thank those from the Committees and Sub Branch enough for the amount of time and effort they put in to ensure our events are run smoothly and professionally. We are all only volunteers but I am amazed at how hard these men and women work together with me as a Team.

We were also assisted by members of the Ingleburn RSL Sub Branch Women's Auxiliary. The Ingleburn RSL Sub Branch Women's Auxiliary is the funding raising arm of the RSL and they work hard throughout the year. The Women's Auxiliary at Ingleburn has also grown during the year and in the space of a few years has gone from 14 members to over 70 members. I urge all ladies over 16 yrs old to join and get involved. The Auxiliary is not restricted to those with links to the military and is a great volunteer fundraising group that assists in our events throughout the year and sell items such as badges and poppies.

DISCUSSION & **ANALYSIS**AS AT 31ST DECEMBER 2014

STATEMENT OF COMPREHENSIVE INCOME

The entity's total revenue has increased by \$1,103,807 (8.23%) since the prior year.

Whilst total expenses have increased by \$408,023 (3.75%) resulting in a net profit after tax of \$1,629,675 (income tax: NIL) compared to \$1,222,692 (income tax: NIL) for the previous year.

Individual items that have impacted the 2014 result include:

Net clearances from poker machines increased by \$1,089,980.

Gaming duty increased by \$291,928.

Interest received increased to \$42.657.

Bar sales have decreased by \$55,902.

Cost of sales has decreased by \$9,214 as a result of decrease in sales.

Bar Gross Profit percentage decreased from 60.00% to 59.51%.

Entertainment, marketing and promotional costs decreased by \$22,978.

Employee benefit expenses increased by \$275,041.

Depreciation and amortisation expenses increased by \$310,857.

Donation expenses increased by \$73,109.

STATEMENT OF FINANCIAL POSITION

The entity's net asset have increased by \$1,629,675 or 18.07% since the previous year consisting of a increase in total assets of \$1,740,798 and a \$111,123 increase in total liabilities.

This increase/decrease in net assets for the year is mainly attributed to:

Increase in property, plant and equipment including leasehold improvements was \$1,444,890, less the difference between depreciation and amortisation of (\$1,482,531) resulting in the net additions of \$37,641.

Increase in receivables of \$70,481.

Increase in cash and cash equivalents by \$1,711,324.

Decrease in inventories by \$3,366.

Increase in employee benefits provision of \$275,041.

Decrease in membership subscriptions in advance of \$10,000.

CASH FLOW STATEMENT

Operating activities provided net cash flow of \$3,219,599 an increase of \$1,711,324 or 87.78% when compared to the previous year.

Net cash used in investing activities of \$1,444,890 related to payments for property, plant and equipment including capital works, renovations and leasehold improvements also Bank Loan mortgage repayments were \$63,385.

As a result of these cash flows, the net cash held during the year increased by \$1,711,324 compared to the previous year's increase of \$346,153.

Cash at year end was \$3,661,035 compared to \$1,949,711 in the prior year.

7 MUTUALITY PRINCIPLE

Ingleburn RSL Sub-Branch Club Limited calculates its income in accordance with the mutuality principle which excludes from income any amounts of subscriptions and contributions from members, and payments received from members for particular services provided by the club or association, eg poker machines, bar and dining room service in the case of social clubs. The Commissioner of Taxation accepts this method of calculating income as appropriate for recognised clubs and associations such as Ingleburn RSL Sub-Branch Club I imited.

Following the recent Full Federal Court decision in Coleambally Irrigation Mutual Co-operative Limited v FCT [2004] FCAFC 250, Tax Laws Amendment (2005 Measures No. 6) Bill 2005 was tabled in Parliament on 7 December 2005 to amend the Income Tax Assessment Act 1997 to restore the long-standing benefits of the mutuality principle to those non-profit organisations affected by the Coleambally decision.

These amendments will ensure social clubs continue not to be taxed on receipts from contributions and payments received from members.

7 NAME CHANGE

On the 1st of May 2013 the Club ceased to be a co-operative, and changed its name to Ingleburn RSL Sub-Branch Club Limited, being a company limited by guarantee under the Corporations Act 2001.
