#### NOTICE OF ANNUAL GENERAL MEETING

Election results will be declared at the Club's AGM held on Thursday 21st April 2016.

#### FIRST ORDINARY RESOLUTION

- "(a) That pursuant to the Registered Clubs Act the members hereby approve and agree to expenditure by the Club in a sum not exceeding (\$90,000) over the following 12 months until the next Annual General Meeting of the Club for the following expenses subject to approval by the Board of Directors:
  - (i)The reasonable costs of directors attending seminars, lectures and other educational activities as determined by the Board from time to time.

- (ii) The reasonable costs (including travel and accommodation expenses and other reasonable out of pocket expenses) of directors attending meetings, conferences and trade shows conducted by ClubsNSW, the Club Directors Institute, the Club Managers Association and the RSL Clubs Association and such other conferences and trade shows as determined by the Board from time to time.
  - (iii) The reasonable cost of directors attending any other registered club for the purpose of viewing and assessing its facilities as determined by the Board as being necessary for the benefit of the Club.
  - (iv) The reasonable cost of directors and partners of directors attending any club, club industry, community or charity functions the representatives of the Club and authorised by the Board to do so and the reimbursement to Directors of reasonable out of pocket expenses when representing the club at these functions.
  - (v) The reimbursement of reasonable out of pocket expenses incurred by directors travelling to and from any additional or special Board meetings or other duly constituted meetings of any committee of the Board.
  - (vi) The reasonable cost of a meal and beverage for each director before and after a Board or committee meeting on the day of that meeting when such meeting coincides with a normal meal time.
  - (vii) The reasonable expenses incurred by directors either within the Club or elsewhere in relation to such other duties including entertainment of special guests of the Club and other promotional activities approved by the Board on production of documentary evidence of such expenditure.
  - (viii) The reasonable cost of directors entertaining guests whilst they are on duty at the Club provided such entertaining is limited to meals, beverages and internal shows.
  - (ix) The reasonable cost of supplying Directors with a Club blazer, a Club tie, trousers and a Club shirt.
  - (x) The provision of designated car parking spaces for directors in the Club's car park.
- (b) The members acknowledge that the benefits in paragraph (a) are not available for members generally but are only for those who are Directors of the Club."

#### NOTES TO MEMBERS ON THE FIRST ORDINARY RESOLUTION

1. The first Ordinary Resolution is to have the members in general meeting approve various expenditure by the Club for directors including to attend seminars, lectures, trade displays and other similar events to be kept abreast of current trends and developments which may have a significant bearing on the Club and for other out of pocket expenses. Included in the First Ordinary Resolution is the cost of directors attending functions as representatives of the Club and the costs of their spouses/partners also attending those functions.

#### SECOND ORDINARY RESOLUTION

- "(a) That the members hereby approve the payment of the following honorariums to the directors of the club for services as directors of the Club until the Annual General Meeting in 2017:
  - (i) President \$10,000.00; and
  - (ii) Directors other than the President \$5,000.00 each.
  - (b) Such honorariums to be paid by monthly or other instalments as the Club and President and the Club and each director may agree from time to time.
  - (c) If the President or a director only holds office for part of the term, the honorarium shall be paid on a pro-rata basis."

# NOTES TO MEMBERS ON THE SECOND ORDINARY RESOLUTION

1. The Second Ordinary Resolution is to have the members in General Meeting approve honorariums for the directors of the Club for duties to be performed by them until the next Annual General Meeting. However, the honorariums will be paid on a pro-rata basis which means that a director who only holds office for part of the year will only receive part of the honorarium. The honorarium proposed this year for the President is \$10,000 and for Directors is \$5,000 which is in recognition of the many hours of voluntary service provided by the President and the other Directors in attending to the Club's business.

#### THIRD ORDINARY RESOLUTION

That the members approve Ingleburn RSL Club absorbing, to a maximum of \$500, the catering cost of the wake of any Life Member of the Club held at the premises of the club.

#### FOURTH ORDINARY RESOLUTION

That the members in accordance with the constitution of the Club approve to admit Raymond O'Neill to Honorary Life Member of the Club

Notes to Members on the Fourth Ordinary Resolution

 The fourth Ordinary Resolution proposes to admit Raymond O'Neill into Honorary Life Membership of the Club

# PROCEDURAL MATTERS IN RELATION TO ALL THE ORDINARY RESOLUTIONS

- To be passed each ordinary resolution must receive votes in its favour from not less than a simple majority of those members, who being entitled to do so, vote in person at the meeting.
- Under the Registered Clubs Act, members who are employees of the Club are not entitled to vote.
- 3. Proxy voting is prohibited by the Registered Clubs Act.

# NOTICE OF SPECIAL RESOLUTIONS FOR ANNUAL GENERAL MEETING

#### PROCEDURAL MATTERS

- To be passed a Special Resolution must receive votes in favour from not less than three quarters (75%) of those members who being eligible to do so vote in person on the Special Resolution at the meeting.
- 2. Each Special Resolution should be read in conjunction with the notes to members which follow each Special Resolution.
- 3. Only Honorary Life members, financial Service members and financial Social members are eliqible to vote on the First Special Resolution.
- 4. Pursuant to rule 46 of the Club's Constitution only Honorary Life members and financial Service members who were previously Service Members, Ordinary Members or Ordinary "A" Class Members are eligible to vote on the Second and the Third Special Resolutions.
- 5. Under the Registered Clubs Act:
  - (a) members who are employees of the Club are not entitled to vote; and (b) proxy voting is prohibited.
- Amendments to the Special Resolutions (other than minor typographical corrections which do not change the substance or effect of the Special Resolutions) will not be permitted from the floor of the meeting.
- 7. The Board of the Club recommends the Special Resolutions to members.

#### FIRST SPECIAL RESOLUTION

[The First Special Resolution is to be read in conjunction with the notes to members set out below.]

That the Constitution of Ingleburn RSL Sub-Branch Club Limited be amended by:

(a) deleting rule 10.4 and replacing it with the following new rule 10.4:

"The number of Full members having the right to vote in the election of the Board shall be not less than such minimum prescribed by the Registered Clubs Act."

- (b) deleting the first sentence in rule 15.10 (which requires the club to notify a new member of their election to membership which is inconsistent with the current practice of the Club) and replacing it with the following sentence:
  - "The Club shall not be required to notify a person if they have been elected to membership".
- (c) adding the following new rule 20.2 (j) and re-numbering existing 20.2 (j) as 20.2 (k):
  - "The Board shall have the power to adjourn, for such period as it considers fit, a meeting pursuant to this Rule 20."
- (d) deleting Rule 29.4 which deals with the quorum needed for a meeting of the Board of Directors and replacing it with the following new Rule 29.4:
  - "The quorum for a meeting of the Board shall be five (5) members of the Board."
- (e) re-numbering Rule 35.13 (c) as rule 35.13 A.
- (f) deleting Rule 38.1 (which deals with accounts and reporting to members) and in lieu thereof inserting the following new Rule 38.1:

#### "ACCOUNTS AND REPORTING TO MEMBERS

#### 38.1 The Board shall:

- (a) cause proper accounts and records to be kept with respect to the financial affairs of the Club in accordance with the Act and the Registered Clubs Act.
- (b) prepare, on a quarterly basis, financial statements that incorporate:
  - the Club's profit and loss accounts and trading accounts for the quarter; and
  - (ii) a balance sheet as at the end of the quarter.
- (c) cause the financial statements referred to in paragraph (b) of this Rule to be submitted to a meeting of the Board.
- (d) make the financial statements referred to in paragraph (b) of this Rule available to members of the Club within forty-eight (48) hours of the statements being adopted by the Board.
- (e) indicate, by displaying a notice on the Club's premises and on the Club's website, how the members of the Club can access the financial statements referred to in paragraph (b) of this Rule.
- (f) provide a copy of the financial statements referred to in paragraph (b) of this Rule available to any member on the written request of the member."

#### NOTES TO MEMBERS ON FIRST SPECIAL RESOLUTION

- The First Special Resolution proposes a series of amendments to the Constitution to bring the Constitution into line with best practice and the requirements of the Corporations Act, Liquor Act, Registered Clubs Act and their associated regulations.
- Paragraph (a) inserts a more appropriate rule dealing with the minimum percentage of members that must be entitled to vote in the election of the Board.
- 3. Paragraph (b) amends the Constitution to remove the requirement for the Club to notify new members of their election to membership of the Club. Under the current practice a person applying for membership is given a membership card and number and the Club does not advise new members that they have been elected to membership. Obviously the Club notifies persons whose membership application is refused.
- 4. Paragraph (c) inserts a provision confirming that the Board can adjourn a disciplinary hearing.
- Paragraph (d) updates the rule dealing with the quorum needed for meetings of the Board of Directors of the Club.
- 6. Paragraph (e) simply corrects some numbering in rule 35.13.
- Paragraph (f) amends the existing provisions relating to Accounts and Reporting to Members to bring the Constitution into line with the Corporations Act.

#### SECOND SPECIAL RESOLUTION

[The Second Special Resolution is to be read in conjunction with the notes to members set out below.]

That the Constitution of Ingleburn RSL Sub-Branch Club Limited be amended by:

- (a) deleting Rules 26.1 and 26.2 which provide as follows:
  - "26.1 Up until the first Annual General Meeting of the Club after the Club becomes registered as a company under the Act, the Board shall consist of nine (9) directors including a President, two (2) Vice Presidents, a Treasurer and five (5) Ordinary directors.
    - The directors in office as at the date the Club becomes registered as a company shall remain in office until the first Annual General Meeting after the Club is registered as a company under the Act.
  - 26.2 As and from the first Annual General Meeting of the Club, after the Club becomes registered as a company under the Act, the Board shall consist of seven (7) directors ("Board members" comprising a President, two (2) Vice Presidents, a Treasurer and three (3) Ordinary directors "
    - and inserting the following new Rules 26.1 and 26.2

- "26.1 The business and affairs of the Club and the control and the custody of its funds shall be managed by a Board consisting of:
  - (a) Seven (7) Directors comprising of a President, two (2) Vice Presidents, a Treasurer and three (3) Ordinary Directors to be elected by the members or appointed by the Board to fill casual vacancies in accordance with this Constitution; and
  - (b) up to 2 directors appointed by the Board pursuant to Rule 26.2
- 26.2 (a) The Board may appoint two (2) directors pursuant to clause 31 of the Registered Clubs Regulation.
  - (b) Any person appointed by the Board to be a director pursuant to clause 31 of the Registered Clubs Regulation only has to satisfy the requirements of that clause to be appointed and does not have to satisfy any requirement in this Constitution including without limitation belonging to a particular category of membership or being a member of the Club for a specific period of time before standing for or being elected or appointed to the Board.
  - (c) A person appointed under subclause (a):
- (i) may be appointed for a term of no more than 3 years, and
- (ii) must be an ordinary member of the club at the time of, and for the duration of, his or her appointment, and
- (iii) is not eligible for re-appointment under subclause (a), including re-appointment after the end of that term.
- (d) Within 21 days of an appointment being made under subclause (a), a notice must be clearly displayed on a notice board on the premises of the registered club and on the club's website (if any) that states:
  - (i) the reasons for the person's appointment, and
  - (ii) the person's relevant skills and qualifications, and
  - (iii) any payments to be made to the person in connection with his or her appointment."

#### NOTES TO MEMBERS ON THE SECOND SPECIAL RESOLUTION

- The Second Special Resolution will update rules 26.1 and 26.2 to remove reference to any historical wording relevant to when the Club converted from a co-operative to a company under the Corporations Act and also proposes to provide the Board with the power to appoint up to two (2) directors to the Board (who are not elected by members or appointed by the Board to fill casual vacancies).
- The Registered Clubs Act and Registered Clubs Regulations enable boards of registered clubs to appoint up to two (2) directors (who are not elected by members or appointed by the Board to fill casual vacancies) to the Board.
- 3. If the Second Special Resolution is passed, the Board may appoint up to two (2) directors to the Board.
- 4. For the avoidance of doubt:
  - (a) the directors appointed to the Board are in addition to the seven (7) directors elected by members or appointed by the Board to fill casual vacancies so the Board could consist of 9 directors; and
  - (b) the Board is not required to appoint persons to the Board but it may do so if it wishes:
  - (c) any person appointed by the Board to be a director only has to satisfy the requirements of the Registered Clubs Act and Registered Clubs Regulations to be appointed and does not have to satisfy any requirement in this Constitution such as belonging to a particular category of membership or being a member for a specific period of time before standing for or being elected or appointed to the Board such as rule 26.6 which requires elected Board members to have been members of the Club for at least 2 years before election to the Board;
  - (d) if a person is appointed to the Board, the Club must, within twenty one (21) days of the appointment, display a notice on the Club's noticeboard and website stating:
    - (i) the reasons for the person's appointment, and
    - (ii) the person's relevant skills and qualifications, and
    - (iii) any payments to be made to the person in connection with his or her appointment.
- This amendment allows the Board to identify persons with particular skills, expertise and experience which may be beneficial to the Club and allow the Board to appoint those persons to the Board.
- 6. For example, the Club may undertake a major construction project in the future and none of the directors at the time may have expertise in construction. This amendment allows the Board to identify and appoint a person or persons with expertise in construction who will be able to assist the Club in completing the construction project.

#### THIRD SPECIAL RESOLUTION

[The Third Special Resolution is to be read in conjunction with the notes to members set out below.]

That the Constitution of Ingleburn RSL Sub-Branch Club Limited be amended by:

- (a) inserting the following new Rule 26.10:
  - "26.10 Any person who is elected or appointed to the Board, must, unless exempted, complete such mandatory training requirements for directors as required by the Regulations made under the Registered Clubs Act."
- (b) inserting the following new Rule 34.1(j):
  - "(j) fails to complete the mandatory training requirements for directors referred to in Rule 26.10 within the prescribed period (unless exempted)."

#### NOTES TO MEMBERS ON THE THIRD SPECIAL RESOLUTION

- Paragraph (a) inserts a new provision relating to the mandatory training requirements for directors as required by the Regulations made under the Registered Clubs Act.
- Paragraph (b) amends the Casual Vacancy provisions in the Constitution to provide that failure to carry out any mandatory training will lead to a casual vacancy arising in the office of director.

#### NOTE TO MEMBERS REGARDING FINANCIAL QUERIES

Members who wish to raise any queries or seek information at the Annual General Meeting about the Financial Report or other matters pertaining to the affairs of the Club, are asked to give the Chief Executive Officer notice in writing of their queries or requests by Friday 15th April 2016. This will enable properly researched replies to be prepared for the benefit of Members.

It is again my pleasure to present to you, my President's Report for this year and to announce your Club has made a Cash Profit of in excess of \$4.7 million dollars and a net Profit of in excess of \$3 million dollars for the year ending 31st December 2015. Although amounts do include the Capital profits of the Sale of two Properties the Club owned (\$421,820.00) and the sale of the old Club Bus, it remains an outstanding achievement. Total Cash profit for 2015 was \$4,710,413.00 as against \$3,112,206.00 for 2014. And this due to the ongoing management skills and initiatives of our Club's Chief Executive Officer, Mr. Glenn Cushion and his outstanding Management Team and indeed all of the RSL Club's hard working and dedicated staff, for without all their contribution and continued input and professional attitude to their duties, such a result may well have not have been attained. Well done and congratulations to Mr. Cushion, the Club Managers and all of the Club's Staff.

As your Club has always endeavoured to maintain such services and promotions that would appeal to the members and their guests, it would appear that your Club had been successful in such activities to the Members satisfaction for without such Services such a result would never had been obtained. Further, a perusal of your Club's Financial Statement for year ending December 2015 will reveal that your Club is no longer in Debt (No Commercial Loan outstanding) a further record and a very satisfying situation for your Club to be in, particularly with today's unsettling financial trends.

As I have mentioned in previous reports, although it is wonderful to have made such income, all such funds will be returned back into the Club and our local community by way of Promotions, activities and entertainment, the ongoing maintenance, the new improvements and renovations to the Club House and in Club Grants to the community groups and to better the experience of all the Club's Members and their guests.

As members will have by now noticed, the Renovations being carried out in the outdoor gaming area, Crystal Lounge Bar area and the backhouse areas have all been completed and I would be sure most Members would agree, the new areas look excellent. I believe it is a credit to our Architects, Altis and Builders, Paynter Dixon for their great work, their attention to detail and that the final presentation is indeed, superb. With the new carpet laid and the enhanced ceiling domes adding to the change, I feel sure the beautiful image of Lady Luck behind the new Crystal Lounge Bar will be called into

service from time to time by most of the members enjoying a flutter for that little extra luck.

May I congratulate Mr. Ray James, our Sub-Branch President and the Sub-Branch members for the excellent ANZAC day service of 2015 and of the referenced of it being the hundred year anniversary of the ANZAC landings on Gallipoli. The mornings Dawn Service was very much appreciated by the thousands of locals that were in attendance on the morning. May we extend our sincere best wishes to all our Sub-Branch members for a happy healthy 2016.

Our thanks go to Rob and Lisa Montgomery, our catering managers for their fine food in the Bistro and to all their hardworking staff in the kitchens and the coffee shop.

Your Clubs holiday units at Forster are now under new management with the appointment of Greg and Jill as the unit's new managers. Numerous changes have now been undertaken since their appointments with a number of units being upgraded and more new furnishings being installed. The manager's residence has been renovated and upgraded for the first time in many years. I must congratulate Greg and Jill for their appointment and indeed for their input and contribution they have already made to improve the amenities and presentation of our units in the short period of time since their appointment. Well done and thank you.

We have had, over the presiding twelve months, seen a number of our staff leave the Club's employ. To these people, may we wish them every success in their new endeavours. To the new staff that have just joined your Club, may we wish them welcome to the team.

A reminder to all members, is of your Club's committed attitude to it's responsibilities in regard to the RSA and RCG Laws. Any such members in violation of the RSA and RCG Laws, may well lose their membership forthwith.

In conclusion, may I, on behalf of your Club's Board of Directors, the Club's CEO and indeed, on behalf of all the Staff, thank you, the members for your continued support and patronage, for without such support, your Club could

not seek to provide the promotions and activities nor the venue that are currently being enjoyed. It is also very much appreciated by your Club, of your patience and perseverance during the recent renovations of the Crystal Lounge area and back of house precinct. Unfortunately, noise and dust during this process was unavoidable however this has now abated thankfully and members can again enjoy some quite respite.

May we wish one and all, the very best for 2016, may we look forward to a prosperous, healthy and a happy year ahead.

## TREASURER'S REPORT

I would like to take this opportunity to present as Treasurer of Ingleburn RSL Club Limited the results for the period ending 31st of December 2015. I am pleased to advise the members that the Club made a profit for the year ending the 31st Dec 2015 of \$3,015,938 after tax compared to last year's profit of \$1,629.675.

EBITARD PERFORMANCE, clubs aim to achieve a minimum of 15% or ideally long term of 20%. I am pleased to tell you that our EBITARD IS 26%. This is outstanding and places us in good standing for the future.

I would like to thank the Chief Executive Officer Mr Glenn Cushion and his PA, Tanita Coulter and his team for their continuing support over the year 2015. I would also like to thank Mrs Jenifer Collins and Wendy Summer for their support with the accounts, well done. I would like to also acknowledge my fellow Directors, thank you.

#### STATEMENT OF COMPREHENSIVE INCOME

The club had an operating profit of \$3.072,390 less income Tax of \$56.452 being a profit of \$3.015,938 for the year ending 2015 compared to \$1,629.675 the previous year.

Individual items that have impacted the 2015 year:

Poker Machines; net profit received from poker machines increase from \$6,254.751 in 2014 \$7,234.437 an increase of \$979,686 915.76%.

Bar; bar sales have increased from \$2,670.196 2014 to \$2,726.016 a marginal increase of \$55,820 a profit of \$548,525 compared to \$492,240.

Catering; resulted in a profit of \$38,733 compared to a profit in 2014 of \$49,760 being a downturn of \$11,027. This was due to expense items causing attention.

Forster Accommodation; Forster had a disappointing result being a loss of \$129,293 compared with a loss (\$36,745-2014) being an increase in losses of \$83,548.

TAB/Keno; Keno commission decreased from (\$150,464-2014) to \$144.888 while other expenses remained consistent, which resulted in Keno making a profit of \$125,305(\$129,133 -2014) down \$3,828.

TAB; commission decreased from (\$59,592-2014) to \$55,620. Operating expenses remained the same, and this resulted in a loss of (\$11,958 compared to a loss of (6,021-2014) an increase in losses of \$5,193.

#### STATEMENT OF FINANCIAL POSITION

The entities net have increased by \$3,015,938 or 26% for the year ending 31st December 2015, compared to the previous year of \$1,629.675 up \$1,629.675. That included Capital profits on sale of assets of \$493,111, being sale of 71 Carlisle Street, Ingleburn of \$421.756 and 19 Minchinbury Terrace, Eschol Park \$63,855, and profit on disposal of the clubs bus \$7,500

with the add-back of depreciation and amortization of \$1,696.475,the result was a cash profit of \$4,710,413,a great result.

#### CASH FLOW STATEMENT

Operating activities provided net cash flow of \$4,710.413 an increase of \$1,597.924 or 95.28%. The club has accumulated cash in bank of \$5,401.000. Our IMB loan reduced to nil. The members' equity in the Club has risen from (\$10,651.000-2014) to \$13,723.840 a good result for the members.

The Club has just carried out a \$2,600,000 mil upgrade of the crystal outdoor area. So as you can see we are moving well in the right direction and still have things to happen. We are still working to our new Strategic Plan and need to look for more for the future of the Club for our members to be proud off.

Again I would like to thank my fellow Board members, the Chief Executive Officer and his team, and our staff for their effort and support in 2015.

I would like to thank our loyal members for their continuing service thank you again as we look towards 2016.

# DISCUSSION & **ANALYSIS**AS AT 31ST DECEMBER 2015

#### STATEMENT OF COMPREHENSIVE INCOME

The entity's total revenue has increased by \$2,292,985 (15.79%) since the prior year.

Whilst total expenses have increased by \$627,466 (5.511%) resulting in a net profit after tax of \$3,015,938 (income tax: \$56,452) compared to \$1,629,675 (income tax: NIL) for the previous year.

Individual items that have impacted the 2015 result include:

Net clearances from poker machines increased by \$1,665,299.

Gaming duty increased by \$440,034.

Interest received increased to \$70,002.

Bar sales have increased by \$55,820.

Cost of sales has decreased by \$32,208 as a result of decrease in sales after discounts and advantage points.

Bar Gross Profit percentage increased from 59.51% to 61.51%.

Entertainment, marketing and promotional costs increased by \$117,289.

Employee benefit expenses increased by \$118,703.

Depreciation and amortisation expenses increased by \$213,944.

Donation expenses increased by \$338.

Profit from the sale of the two investment properties was \$485,611.

#### STATEMENT OF FINANCIAL POSITION

The entity's net asset have increased by \$3,015,938 or 28.32% since the previous year consisting of a increase in total assets of \$3,064,195 and a \$48.257 increase in total liabilities.

This increase/decrease in net assets for the year is mainly attributed to:

Increase in property, plant and equipment including leasehold improvements was \$3,027,623, less the difference between depreciation and amortisation of (\$1,696,475) resulting in the net increase of \$1,331,148 after the sale of the two investment properties.

Increase in receivables of \$350.

Increase in cash and cash equivalents by \$1,739.966.

Decrease in inventories by \$6,569.

Increase in employee benefits provision of and Income Tax Provision of \$118,703.

Decrease in membership subscriptions in advance of \$3,010.

#### CASH FLOW STATEMENT

Operating activities provided net cash flow of \$4,825,087, an increase of \$1,605,488 or 49.87% when compared to the previous year.

Net cash used in investing activities of \$3,027,623 related to payments for property, plant and equipment including capital works, renovations and leasehold improvements also the Bank Loan mortgage was fully repaid, \$57,498.

As a result of these cash flows, the net cash held during the year increased by \$1,739,966 compared to the previous year's increase of \$1,711,324.

Cash at year end was \$5,401,001 compared to \$3,661,035 in the prior year.

The financial report of Ingleburn RSL Sub-Branch Club Limited complies with all Australian equivalents and the new - Reduced Disclosure Requirements. The presentation currency used in this summary of financial statements is Australian dollars.

It has been prepared on the basis of historic costs and except where stated, does not take into account changing money values or fair values of non-current assets.

The accounting policies have been consistently applied by the Company and are consistent with those in the previous year.

Where necessary, comparative information has been reclassified to achieve consistency with current year amounts and other disclosures.

A full description of the accounting policies adopted by the Company may be found in the Company's full financial report.

#### 7 MUTUALITY PRINCIPLE

Ingleburn RSL Sub-Branch Club Limited calculates its income in accordance with the mutuality principle which excludes from income any amounts of subscriptions and contributions from members, and payments received from members for particular services provided by the club or association, eg poker machines, bar and dining room service in the case of social clubs. The Commissioner of Taxation accepts this method of calculating income as appropriate for recognised clubs and associations such as Ingleburn RSL Sub-Branch Club I imited.

Following the recent Full Federal Court decision in Coleambally Irrigation Mutual Co-operative Limited v FCT [2004] FCAFC 250, Tax Laws Amendment (2005 Measures No. 6) Bill 2005 was tabled in Parliament on 7 December 2005 to amend the Income Tax Assessment Act 1997 to restore the long-standing benefits of the mutuality principle to those non-profit organisations affected by the Coleambally decision.

These amendments will ensure social clubs continue not to be taxed on receipts from contributions and payments received from members.

#### **CORE ASSETS**

Ingleburn Leasehold at 70 Chester Road is considered to be core property.

All other property is non core property as defined under the registered Clubs

Act 1976 Section 41.I.

During the year, a judging panel of well-credentialled amateur as well as local professional photographers were impressed by the quality of work exhibited by such a new club.

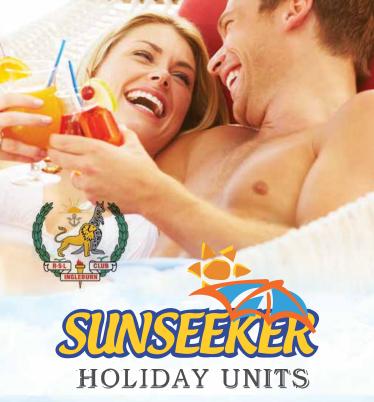
Membership numbers grew throughout the year with a variety of competitions and informative practical sessions, as well as various presentations by the members.
